- An independent private legal entity incorporated / registered in India such as proprietorship firm, partnership firm, limited liability partnership (LLP), Private Limited Company registered under Companies Act 2013, Public Limited Company registered under Companies act 2013 including Joint Ventures, government - owned entities. A group of entities (the "Consortium"), a combination of the above legal entities, with a formal intent to enter into a Consortium agreement.
- The Bidder / any member of the Consortium shall have experience in constructing / curating /managing operations and maintenance of a theme-based Museum / theme parks / interpretation centers/ theme-based restaurants / hotels / event management as on 01.10.2021;
- Average annual Turnover of INR 10,00,00,000/- (INR ten Crore) in the last 3 (Three) financial years i.e. 2017-18, 2018-19, 2019-20.
- The Bidder should not be involved in any major litigations such as fraud, FEMA violations etc.
- All experience certificates must be certified by Chartered Accountant.
