Eligibility Criteria:-

1. Registration Certificate of the company/firm.
2. GST Registration Certificate.
3. Copy of PAN card, duly certified displaying the PAN No.
4. **Mode of Payment towards Tender Document, Fee (TDF), Tender processing Fee(TPF) & Earnest Money Deposit (EMD) to be paid online through e-Payment mode via:**
 - i) **National Electronic Fund Transfer (NEFT)/ Real-Time Gross Settlement (RTGS)/Axis Bank Over the -Counter (OTC). Tenderer should download pre-printed Challan towards credit of ITG available on e-tender website and make its payment through any of their Bank. The bidder will be able to proceed with submission only once the amount has been received in ITG's account.**
 - ii) **Internet Payment Gateway (Debit/Credit Card of type VISA, MASTERCARD or RuPay).**
 - iii) **Net Banking: Payment can be made through the Internet Banking of any Bank.**

Note: Any payments made through NEFT/RTGS/OTC will take 24 hours for its reconciliation. Hence, the payments through NEFT/RTGS/OTC should be made at least TWO BANK WORKING DAYS in advance. The bidder will only be able to proceed with submission after the amount has been credited to ITG's account.
5. Certificate from registered Chartered Accountant clearly stating the annual turnover of **Rupees Six lakhs per annum** for the last three financial years namely 2016-2017, 2017-2018 and 2018-2019.
6. Income Tax Return filed by the Agency for the last three financial years.
7. The bidder should have atleast three years of work experience in supplying curtains etc. in 2 star hotels and above or A, B, C, D category hotels registered with the tourism department.
