- The applicant or any member of the consortium should have at least 1-year experience in operating or managing minimum 2 passenger cruise vessels catering to tourism during the last 5 years.
- The applicant should have minimum 10 years' experience in shipping industry or merchant navy with at least 4 years of sailing experience as engineer / officer.
- Minimum average turnover of INR 1 crore in the last 3 financial years from shipping cruise industry.
- Minimum average net worth of INR 5 Crore in the last 3 financial years.
- The Applicant should be solvent to the tune of INR 50 Lakh.
- The Applicant should not have any conflict of interest or blacklisting as on bid due date.
