- Should own a passenger vessel of a minimum 120 pax for the last one year catering to tourism which has been operating in inland waters of Goa or anywhere in India.
- Should have a minimum net worth of INR 5,00,00,000/- (INR five crore only) as on 31st March 2019
- Should have a minimum average annual financial turnover of INR 1,00,00,000/- (INR one crore only) in the last three financial years
- Should not have any pending litigations, conflict or interest or blacklisting as on bid due date
