- 1. The bidder can be sole proprietor, partnership firm or a Company and the bidder should be registered with EPF Office & ESIC Office and should be in existence for minimum five years proof to be furnished.
- 2. A. copy of ISO 9001:2008 certificate valid as on the date of submission of Bid is preferable.
- 3. A copy of PAN No. and Service Tax Registration to be furnished.
- 4. Earnest Money Deposit of Rs. 1,00,000/- by electronic mode or Demand Draft
- 5. The bidder should have average Annual turnover of Rs. 100.00 lakhs in last three years i.e. 2011-12, 2012-13 & 2013-14. Audited Balance Sheet along with certificate from Chartered Accountant clearly showing the turnover, should be attached as per the attached format.
