**Eligibility Condition:**

1. The bidders/lead member who fulfills the following requirement shall be eligible to apply.
  - (i) The bidder should be a Private Limited Company / Public Limited Company/ Partnership or Proprietary firm. The bidder should submit valid Incorporation/ Registration certificate, PAN Card and Goods and Services Tax (GST) certificate/ number;
  - (ii) Intending Bidder should be in the business of boats, marine goods, water sports sector and should have adequate experience of successful supplying Rescue Boat with OBM in India in last 5 years (prior to the date of tender). Relevant Purchase order copy should be submitted along with the Bid;
  - (iii) Bidder must be a manufacturer or the authorized distributors / dealers / agents of Rescue Boat and should submit their valid and current authority letters.
  - (iv) Bidder should have necessary after sales service facilities and service center in India with OEM factory – trained team of technicians for repairs and service of boat & engines.
  - (v) Intending bidder should have experience in supply of minimum 05 Rescue Boat manufactured under Indian Vessels Act, 1917 in India. Proof of such experience to be attached;
  - (vi) Intending bidder should have the annual average turnover of Rs. 4.00 Crore or above during the last three financial years ending 31st March, 2017. Audited balance sheet of relevant accounts duly certified and stamped by the Chartered Accountant shall be produced (Provisional Document duly attested by Chartered Accountant can be also be submitted);
  - (vii) The bidder should not have been blacklisted by GTDC, Public Sector Undertaking, Semi-Government Organizations and other Government undertakings in India; and
  - (viii) No JV/Consortium is allowed.
  
2. The intending bidder should scan and upload the following certificates for issue of tender documents
  - a. Registration Certificate of the company/firm
  - b. Attested copy of PAN CARD.
  - c. Attested copy of valid GST registration Certificate
  - d. Certificates of similar work experience
  - e. Certificate of Financial turnover from CA.
  - f. Bank Solvency Certificate.
  - g. Affidavit of works in hand.

3. The intending bidder/s must read the terms and conditions of RFP carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
4. Information and Instructions for bidders posted on website shall form of bid document.
5. The bid document consisting of RFP of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website [www.tenderwizard.com/GOA](http://www.tenderwizard.com/GOA) Or [www.etender.goa.gov.in](http://www.etender.goa.gov.in) and for participation in e-tender website visit [www.tenderwizard.com/GOA](http://www.tenderwizard.com/GOA) on payment of fees for tender document and tender processing.
6. Mode of Payment towards Tender Document Fee(TDF), e-Tender Processing Fee(TPF) & Earnest Money Deposit(EMD) to be paid online through e-Payment mode via:
  - i. National Electronic Fund Transfer (NEFT) / Real-Time Gross Settlement RTGS) / Axis Bank Over-the-counter (OTC). Tenderer requires download pre-printed Challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.
  - ii. Internet Payment Gateway (Debit/ Credit Card of type VISA, MASTERCARD or RuPay.
  - iii. Net Banking: Payment can be made through the Internet Banking of Any Bank. Those contractors not registered on the website mentioned above, are required to get registered beforehand.
7. The Certificate of Financial Turnover - at the time of submission of the bid the contractor may upload affidavit/certificate from CA mentioning financial turnover of last three years or for the period as specified in the bid document.
8. The last date for application for the tender documents shall be **22<sup>nd</sup> December 2017 upto 4:00pm**, Last date for online issue of tender documents **26<sup>th</sup> December 2017**, and the last date of submission of the technical bid and the financial bid shall be **12<sup>th</sup> January 2017 upto 3:00pm**.
9. The technical bid documents opening shall be informed later and the opening of financial bid of the contractors qualifying the technical bid shall be communicated to them at a later date.
10. **Pre bid conference** shall be held in the Board Room at 3<sup>rd</sup> **Floor, Paryatan Bhavan Panaji on 04<sup>th</sup> January 2018 at 03:00 pm** ,to clear the doubt of the intending bidders if any.
11. The GTDC reserves the right to reject any or all the tenders without assigning reason thereof.
12. Incomplete applications shall be summarily rejected.
