## Redevelopment, Operations and Maintenance of GTDC Property at Britonna on Private Investment Mode ( Retender)

Goa Tourism Development Corporation Limited (GTDC) invites e-tenders from single entities, joint ventures, and consortia for "Redevelopment, Operations and Maintenance of GTDC Property at Britonna on Private Investment Mode (Retender)" with the following minimum eligibility criteria:

- Independent private legal entity incorporated / registered in India: proprietorship concern, partnership firm, Limited Liability Partnership (LLP), private limited company registered under Companies Act 1956 or 2013, public limited company registered under Companies Act 1956 or 2013 including, government-owned entities. A group of entities (the "Consortium"), a combination of the abovementioned legal entities, with a formal intent to enter into a Consortium agreement. Consortium of maximum 3 (three) members is allowed. Except the lead bidder, other members of the consortium shall be in existence for minimum 2 (two) years prior to the Bid Due Date and as part of the supporting document, the respective certificate of incorporation shall be submitted along with the technical proposal.
- The Bidder / any member of the consortium should have experience in development or operations and maintenance of 3-star or higher category Hotels / Resorts with at least 40 (Forty) rooms anywhere in the world for a period of at least 3 (Three) years anytime before the bid due date.

## OR

- The Bidder/consortium for the purpose of this project must have entered into a MOU/Management/Franchise Agreement with a well-known technical partner or reputed brand with the following criteria:
  - A. The technical partner should have expertise in development or operations and maintenance 3-star or higher category Hotels / Resorts with at least 40 (forty) rooms anywhere in the world for a period of at least 3 (Three) years anytime before the bid due date;
- The Bidder should have Average Annual Turnover (combined average annual turnover for consortiums) in any 3 (three) years of last 5 (five) financial years i.e 2019-20, 2020-21, 2021-22,-23 and 2023-24 should be at least INR 10,00,00,000/- (INR Ten Crore Only).
- The Bidder should have at least a net worth of INR 5 crore as on 31.03.2024.

- The Bidder (single entity / any member of the Consortium):
  - a) Should not be involved in any major litigation such as fraud and FEMA violations.
  - b) Should not be involved in any conflict-of-interest situation.
  - c) Should not have been blacklisted by any Central Government / State Government / PSU in India.
  - d) Should not have any active disputes with Department of Tourism (Government of Goa) or Goa Tourism Development Corporation Limited.
  - e) Should not have been disqualified in any tenders of Dept. of Tourism, Govt of Goa or Goa Tourism Development Corporation Limited (GTDC) in the past due to material misrepresentation or fraudulent submission of any documents.
  - f) All experience certificates must be certified by Chartered Accountant
