Goa Tourism Development Corporation Limited (GTDC) invites e-tenders from single entities, joint ventures, and consortium for Development, Operation and Maintenance of Passenger Ropeway between Panjim and Reis Magos in Goa through Public-Private Partnership basis.

Technical criterias are as below:

- Independent private legal entity incorporated / registered in India: proprietorship concern, partnership firm, Limited Liability Partnership (LLP), private limited company registered under Companies Act 1956 or 2013, public limited company registered under Companies Act 1956 or 2013 including, government-owned entities. A group of entities (the "Consortium"), a combination of the abovementioned legal entities, with a formal intent to enter into a Consortium Agreement. Consortium of maximum 3 (three) members is allowed. Except the Lead bidder, other members of the consortium shall be in existence for minimum 2 (two) years prior to the Bid Due Date and as part of the supporting document, the respective certificate of incorporation shall be submitted along with the technical proposal.
- The Bidder should satisfy the below mentioned Technical criteria:
 - 1) The bidders should have an experience of installation, operation & maintenance of atleast ONE Passenger Ropeway with minimum carrying capacity of 500 PPH anytime before the bid due date. The interested bidders not able to meet the technical experience on their own, can participate in the bidding process by entering into an Engineering, Procurement and Erection & Commissioning Contract with a supplier / entity of international repute meeting the following qualification criteria:
 - a) Experience of atleast 15 years in the industry,

- b) Experience of installing & commissioning Ropeway systems adhering to CEN standards,
- c) Experience of successfully installing & commissioning at least ONE Detachable Passenger Ropeway, anywhere in the world, conforming to CEN Standards with minimum carrying capacity of 500 PPH anytime before the bid due date and whose combined value is at least Rs.50 Crore.
- The Bidder should have Average Annual Turnover (combined average annual turnover for consortiums) in any 3 (three) years of last 5 (five) financial years i.e 2019-20, 2020-21, 2021-22, 2022-23 and 2023-24, of at least INR 8,00,00,000/- (INR Eight Crore Only).
- The Bidder should have net worth of at least 20 Croreas on 31.03.2024.
- The Bidder (single entity / any member of the Consortium):
 - a) Should not be involved in any major litigation such as fraud and FEMA violations.
 - b) Should not be involved in any conflict-of-interest situation.
 - c) Should not have been blacklisted by any Central Government / State Government / PSU in India.
 - d) Should not have any active disputes with Department of Tourism (Government of Goa) or Goa Tourism Development Corporation Limited.
 - e) Should not have been disqualified in any tenders of Department of Tourism, Government of Goa or Goa Tourism Development Corporation Limited (GTDC) in the past due to material misrepresentation or fraudulent submission of any documents.
 - f) All experience certificates must be certified by Chartered Accountant.
