### Terms & conditions.

- 1) The period of agreement for hire of vehicle will be for a minimum of 1 year, renewable every year.
- 2) The rate shown in the chart will be increased by 5% on 1<sup>st</sup> April every year on the initial quoted rate. Accordingly, you may take Government approval.
- 3) The vehicle will be in good condition with valid RTO permits and in white colour.
- 4) The cost quoted is inclusive of driver salary, oil, fuel, maintenance and Insurance of vehicle as well as 3<sup>rd</sup> party insurance.
- 5) The vehicle will be available from 9.00 am to 7.00 pm.
- 6) Extra hour charges will be applicable after 7.00 pm to 9.00 am.
- 7) GTDC has to pay time bound bills of operators hence payment should be made within 30 days of submission of bill. In case payment is not received within 30 days then the vehicle will be withdrawn with immediate effect.
- 8) After requisition for vehicle minimum 15 days or more will be required to arrange the vehicle.
- 9) One-month notice will have to be given for discontinuation of vehicle once allotted with valid reason.
- 10) It may be noted that as per the Government of India GST slab, the handling (Administrative) charges falls under 18% GST & 5 % GST for actual usage of vehicle.
- 11) These rates shall remain valid until further orders.

You are requested to obtain financial approval of the Government of Goa before placing the order so that the payment of the vehicle vendors are not delayed.
