The application of the intending Bidder/Vendor's should accompany the following documents.

INITIAL ELIGIBILITY FOR EVALUATION OF TECHNICAL BID

The bidder should scan and upload the following documents for being eligible for evaluation of technical bid:

- 1) Independent private legal entity incorporated / registered in India: proprietorship concern, partnership firm, Limited Liability Partnership (LLP), private limited company registered under Companies Act 1956 or 2013, public limited company registered under Companies Act 1956 or 2013 including, government-owned entities.
- 2) The bidder should specify the type of firm (Sole proprietor/ Partnership firm or company) and submit related registration documents.
- 3) Bidder should submit the copy of PAN card, GST registration.
- 4) Bidder should have atleast 3 years of experience in Housekeeping Facility Management and Allied Services from reputed hotels/Government guest houses in the last 5 financial years (40 rooms minimum).

- 5) The bidder should have an average annual financial turnover of Rs.50 lakhs related to housekeeping works for any three of last four Financial Years ending i.e F.Y 22-23, 23-24, 24-25 and 25-26.
- 6) The Bidder (single entity /any member of the Consortium) shall submit Undertaking stating:-
- a) Bidder Should not be involved in any conflict-of-interest situation.
 - b) Bidder Should not have been blacklisted by any Central Government / State Government / PSU in India.
 - c) Bidder Should not have any active disputes with Department of Government of Goa.
 - d) Bidder Should not have been disqualified in any tenders of Dept. of Tourism, Govt of Goa or Goa Tourism Development Corporation Limited (GTDC) in the past due to material misrepresentation or fraudulent submission of any documents.
 - e) All experience certificates must be certified by Chartered Accountant.
- 7) The bidder should have Registration or service office in the State of Goa.
